Of year for teachers plus another in middle of year. Stats - 28% decrease in behavioral problems in schools (where is data from). Great morning starter, reset after recess or end of day wrap up. Could start mid-year. Daily activity/2 lessons/week Will send data to Hilaree and forward to council. How will it fit in the teachers day.

District would like each day Welcome and inclusion morning meeting, Mid-day Brain break, Optimist ending - Is one issue the constant digital glut? Covid was issue and, sending devices home, Hilaree Will present at JSSC meeting.

3. Report on meeting with DSD superintendent – LeeAnne and Hilaree

Bond, community partnership with Kaysville city to accomplish items, SEL Growth mindset, mindfulness, deliberately indifferent doj investigation outcome, harassment student to student/ black and asian students, Staff to student, and black students were not allowed to form cultural groups. Yes there was wide spread 100's of incidents, the way it was reported, investigated, documented was deliberately indifferent. Receives 20 reports daily right now. Victim/ complaints of harrasmenet was not given support, attention given to perpetrator/. They are really trying to make systemic change in the district. Weekly meetings with DOJ. House bill 428 passed, requiring all districts to comply with the same things.
